Hangar Information

The City of Naples Airport Authority (the “Authority”) offers executive hangars, t-hangars, shade hangars and storage units for lease. Current rental rates are published in the Rates and Charges for the Naples Municipal Airport at www.flynapples.com. **Aircraft must have at least 18 inches of clearance on all sides when stored in Authority-owned hangars.**

✦ **Shade Hangars** (formerly known as T-Shelters)

- 20 Units
- Bays are approximately 41' wide, 12' high and 32' deep
- Two units are available at a reduced price for aircraft with a wingspan of 32' or less.

✦ **End Unit Hangars**

- 2 Units
- Suitable for small aircraft, including those with folding/removable wings, small experimental and small, single-blade helicopters

✦ **Standard T-Hangars**

- 153 Units
- Clear openings are approximately 40' – 42' wide, 12' high and 32' deep
- Suitable for most single-engine airplanes and small helicopters

✦ **Large T-Hangars**

- 46 Units
- Clear openings are approximately 45' – 47' wide, 14' high and 37' – 38' deep
- Limited to aircraft that will not fit in Standard T-Hangars, which include:
 - Aircraft with a wingspan of 38' or greater; or
 - Aircraft with other dimensions that make it unsuitable for Standard T-Hangars, as determined in the sole discretion of the Authority.

✦ **Cabin T-Class Hangars**

- 9 Units
- Clear openings are approximately 56' wide, 16' high and 40' deep
- Limited to aircraft that will not fit in Standard or Large T-Hangars, which include:
 - Aircraft with a wingspan of 43' or greater; or
 - Aircraft with other dimensions that make it unsuitable for Standard or Large T-Hangars, as determined in the sole discretion of the Authority.

✦ **Executive Hangars** (common/bulk storage)

- Clear openings are approximately 90' – 99' wide, 22' – 24' high and 81' – 120' deep
- Rental rate is based on the dimensions of the aircraft (length x width)
- Rental rate includes towing services

✦ **T-Hangar Storage Units**

- Small, medium and large units available with personnel doors
- Large and X-Large units available with overhead, roll-up doors

_____ Hangar waitlist reservations require payment of a Hangar Request Fee. Fees are non-refundable, except
initials under the following circumstances:

- ✈ Applicant submits a written request to be removed from the waiting list prior to being offered a lease opportunity; or
- ✈ The Authority determines that it cannot/will not accommodate the aircraft in any of its hangars.

_____ When a hangar is available, Authority staff will attempt to contact the applicant for ten (10) days. If
initials the applicant cannot be reached within that time, the applicant will be removed from the waiting list and the hangar request fee will be forfeited.

_____ An applicant may opt to reject an offer of an available hangar one (1) time. A second refusal will result
initials in removal of the applicant from the waiting list and the hangar request fee will be forfeited.

_____ It shall be the responsibility of each applicant to advise the NAA regarding changes to their contact
initials information, including mailing address, email and telephone number.

_____ Current aircraft ownership is not required to reserve a place on the waiting list; however, an appropriate
initials aircraft must be owned within ninety (90) days of lease commencement. If an aircraft is not obtained within that time, the lease will be terminated, and all monies paid shall be forfeited.

_____ Naples Airport reserves the right to give priority to current tenants for hangar transfers, and to change
initials or cancel a reservation for a hangar that does not meet the minimum or maximum size criteria, which determination shall be in the sole discretion of the Authority.

_____ A position on the waiting list shall not be sold, gifted or transferred.
